General Details / Operating Condition:

Commencing at 0700 hours on Tuesday 19th November 2024 to 0500 hours Friday 22nd November 2024, or until the works are completed, the following infrastructure upgrading works will be undertaken at Branxton:

- Book out of use and permanently remove number 122A/B points machines and associated equipment, and
- Install, commission and book into use new 122A/B, D84 MKIII electric points machine and associated equipment.
- Book out of use and permanently remove number 122C/D points machine and associated equipment, and
- Install, commission and book into use new 122C/D, D84 MKIII electric points machine and associated equipment.

The commissioning of these new arrangements will involve route-setting activities, signal testing and point testing.

In addition to the crossover renewal, the existing track side permanent speed signs will be reduced for crossover movements of Express Services, as detailed below.
