From 0700hrs Thursday, 16th January 2025 the following will be carried out for the Alice Street Level Crossing, Moree at 665.846km:

- Relocation of the strike-in-point.

Safeworking Arrangements:

All work must be carried out as per the appropriate ARTC Network Rules and Procedures. As required works are to be completed using Track Occupancy Authorities (TOAs) on an as traffic permits basis.

As required an Infrastructure Booking Advice form (ANRF 003) must be compiled as per ARTC Rule ANWT 312 Infrastructure Booking Advice and Procedure ANPR 704 Using Infrastructure Booking Advices, to book out of use and back into of use the level crossing infrastructure.
