General Details / Operating Condition:

On Monday 7th April 2025, Telstra will commission cabling upgrade works between Murrumbo and Kerrabee. These works will result in a single outage of the Telstra 4G mobile service for up to 30 minutes between 1300 hours and 1330 hours while the new cable is being connected to the network.

During the outage ICE radio communications will instead connect to Broadmeadow NCCN via satellite mode and the backup satellite system will provide communication within Ulan Cox's Gap No. 1 Tunnel.

Systems and devices reliant on Telstra 4G mobile service may experience connection issues and dependency on their use should be avoided between 1300 hours and 1330 hours. If possible, repositioning to a location retaining mobile coverage should be considered.

Note: Telstra mobile service outside of the Murrumbo to Kerrabee section will not be impacted by the Telstra works.

Affected Services:

- Telstra 4G mobile service from Murrumbo (exclusive) to Kerrabee (inclusive) will be unavailable for up to 30 minutes,
- ICE Train Radios within the affected area, however they will instead operate in satellite mode when the Telstra 4G service is temporarily interrupted, and
- Systems and devices reliant on the Telstra 4G mobile voice & data service including mobile telephones, eTAP and electronic TOA's

Unaffected Services:

- ICE Radio operation to and from Broadmeadow NCCN, will operate as normal for all calls outside of the affected area,
- The back up satellite communication system for Ulan Cox's Gap No. 1 Tunnel (366.468 367.229km), and
- All communication equipment for Ulan Cox's Gap No. 2 Tunnel (368.335 368.745km).

Additional Details:

During this planned work, ARTC representatives will be located onsite to oversee the Telstra works. They will confirm restoration of the Telstra 4G mobile service and will support the management in the event of any unforeseen issues.
